MARY CALDWELL-WILLIAMS SCHOLARSHIP APPLICATION

Eligibility Criteria

- 1. The Scholarship applicant must be a graduate from an accredited high school during the 2021-2022 academic year.
- 2. Scholarship applicant must have a minimum graduating GPA (grade point average) of 2.0.
- 3. The Scholarship award will be given for the fall or spring semester of the next academic year.
- 4. Scholarship awards will be distributed after the winning applicant provides the Scholarship Committee with proof of enrollment in an accredited post-secondary educational institution.
- 5. All applicants must be sponsored by a subordinate LOCOP court.
- 6. Individual applicants may not submit application directly to the Russell Alexander Earl Sr. Grand Court. Applications must be submitted through a subordinate LOCOP court.
- 7. Three (3) letters of recommendation (1) from instructor/teacher, or employer; one (1) from a member in good standing of the Most Worshipful Union Grand Lodge of Florida, RAESGC LOCOP, Jerusalem Grand Chapter, Order of the Eastern Stars, Heroines of Jericho or Heroines of the Templars Crusade; one (1) from an organizational leader, or religious leader must accompany the scholarship application packet.
- 8. The Scholarship award will be made payable to the selected applicant, rather than to the institution.
- 9. Illegible or incomplete applications will not be considered.
- 10. The complete scholarship application packet must be received by the Mary Caldwell-Williams Scholarship Committee at the address below on or before **March 18, 2022**.
